## THIRD AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF

PARK PLACE VILLAS, A CONDOMINIUM

This Third Amendment to the Declaration of Condominium of PARK PLACE YILLAS, a condominium is made and entered into this 29th day of January, 1988.

WHEREAS, the Declaration of Condominium of PARK PLACE YILLAS, a condominium (the "Declaration"), was heretofore recorded in Official Records Book 1936, Pages 0841 through 0895, and the plat thereof was recorded in Condominium Book 26, Pages 23, 23A and 23B of the Public Records of Sarasota County, Florida; and

WHEREAS, the Decalaration was amended by First Amendment to the Declaration of Condominium of PARK PLACE YILLAS, a condominium dated the 19th day of November, 1987 and recorded the 20th day of November, 1987 in Official Records Book 1991, at Page 0217 of the Public Records of Sarasota County, Florida, and amended by Second Amendment to the Declaration of Condominium of PARK PLACE YILLAS, a condominium dated the 14th day of January, 1988 and recorded the 19th day of January, 1988 in Official Records Book 2003, at Page 0413 of the Public Records of Sarasota County, Florida; and

WHEREAS, ROBERT R. ROGERS, AS TRUSTEE, (the 'Developer'') was, at the time of the creation of PARK PLACE YILLAS, a condominium (the "Condominium"), and is presently, the developer of the Condominium and is so designated in the Declaration; and

WHEREAS, the Developer has the right, in accordance with Article 17 of the Declaration, to amend the Declaration for the purposes set forth in said Article 17; and

WHEREAS, the Developer is desirous of amending the Declaration in accordance with Article 17 thereof in order to reflect the substantial completion of certain of the buildings and units within the Condominium.

NOW THEREFORE, BE IT RESOLVED that the Developer, for himself, his successors, grantees and assigns, shall and does hereby amend the Declaration as follows:

- 1. The Survey, Site Plan and Graphic Description of the Condominium, which comprises Exhibits "A" and "B" to the Declaration, as heretofore amended, (and which is incorporated by reference into the Declaration) is hereby amended by the addition thereto of the Certificates of Surveyor attached hereto as Exhibits "A" and "B", inclusive, and by reference made a part hereof.
  - 2. There are no further amendments.
